A certificate of cancellation of the authority of Acuity Bank to operate as a savings and loan association became effective on April 20, 2007, and the Federal Deposit Insurance Corporation has terminated the association's federal deposit insurance. The entity shall do only those things that are permitted of an institution that has filed the notice to liquidate under Chapters 215 and 180.
