

**CHANGES IN BANK STRUCTURE**

Month ending February 28, 2013

<b>VOLUNTARY LIQUIDATION AND CANCELLATION OF CHARTER</b>	Community Bank of Central Wisconsin, Colby, Wisconsin, voted to voluntarily liquidate and gave notice to the division that the bank would dissolve following the acquisition of substantially all its assets and assumption of deposit liabilities by Citizens State Bank of Loyal, Loyal, Wisconsin, and Forward Financial Bank, SSB, Marshfield, Wisconsin, and the distribution of the remaining assets and liabilities to CBCW Liquidation LLC, a Wisconsin limited liability corporation and subsidiary of the bank's only shareholder, Central Wisconsin Bancorporation, Inc., Colby, Wisconsin. As a result, the charter of Community Bank of Central Wisconsin was cancelled, effective close of business February 1, 2013.
<b>BRANCH ACQUIRED AND ESTABLISHED</b>	Citizens State Bank of Loyal, Loyal, Wisconsin, established a branch at 103 West McMillan Street, Marshfield, Wisconsin, on February 4, 2013, following the purchase of specific assets and assumption of specific deposit liabilities of Community Bank of Central Wisconsin, Colby, Wisconsin, effective close of business February 1, 2013.
<b>BRANCHES ACQUIRED AND ESTABLISHED</b>	Forward Financial Bank, SSB, Marshfield, Wisconsin, established a branch at 1122 North Division Street, Colby, Wisconsin, on February 4, 2013, following the purchase of specific assets and assumption of specific deposit liabilities of Community Bank of Central Wisconsin, Colby, Wisconsin, including the locations at 1122 North Division Street, Colby, Wisconsin, 326 North Central Avenue, Owen, Wisconsin, and 300 North Washington Street, Thorp, Wisconsin, with the Owen and Thorp offices being consolidated with the bank's existing branch locations in Withee and Thorp, effective close of business February 1, 2013.
<b>BRANCH RELOCATION</b>	AbbyBank, Abbotsford, Wisconsin, relocated its branch from 2100 Stewart Avenue, Wausau, Wisconsin, to 305 South 18 <sup>th</sup> Avenue, Wausau, Wisconsin, effective February 4, 2013

BRANCH RELOCATION	River Cities Bank, Wisconsin Rapids, Wisconsin, relocated its branch from 507 Linn Street, Baraboo, Wisconsin, to 110 Linn Street, Baraboo, Wisconsin, effective February 4, 2013
CHANGE IN NAME	ISB Community Bank, Ixonia, Wisconsin, changed its name from ISB Community Bank to Ixonia Bank, effective February 13, 2013
BRANCH CLOSING	Town and Country Bank, Watertown, Wisconsin, closed its branch location at N 1826 County Road R, Lebanon, Wisconsin, effective February 28, 2013
