The staff of the Enforcement Unit, Registration & Enforcement Section, of the Division of Securities, Department of Financial Institutions, State of Wisconsin has conducted an investigation in this matter pursuant to sec. 551.56, Wis. Stats. and as a result thereof alleges as follows:

1. JC Gear.Com ("JC Gear") is a Nevada corporation with a last known business address of 100 E. Linton Blvd., Ste. 150A, Delray Beach, FL 33483 and former business addresses of 1440 SE 10th St., Deerfield Beach, FL 33441-7160, 2965 NE 12th Ave., Pompano Beach, FL 33064, and 211 Mountain Laurel Dr., Cranston, RI 02920-3418.
2. Arthur J. Comeau (DOB 5/16/61) ("AJ Comeau") is an individual who at all times material hereto was President of JC Gear, with a last known business address of 20942 Springs Terrace, Boca Raton, FL 33428.
3. Arthur M. Comeau ("AM Comeau") is an individual who at all times material hereto was Vice President of JC Gear, with a last known business address of 211 Mountain Laurel Dr., Cranston, RI 02920-3418.
4. Kenneth B Barker (CRD#2269570; DOB 4/13/67) is an individual who at all times material hereto was an agent of JC Gear, AJ Comeau and AM Comeau, with a last known business address of 555 S. Federal Hwy., #400, Boca Raton, FL 33432 and a last known residence address of 3422 NE 35th St., Lighthouse Point, FL 33064.
5. During the period of at least 1999, Barker, on behalf of JC Gear, AJ Comeau and AM Comeau, offered and sold to at least two persons in Wisconsin the stock of JC Gear.
6. The stock offered and sold by the respondents are securities as defined by sec. 551.02(13), Wis. Stats., and have never been registered for offer and sale in Wisconsin pursuant to Ch. 551, Wis. Stats.
7. All Respondents have violated sec. 551.21(1), Wis. Stats., by offering unregistered securities in Wisconsin.
8. In connection with the offers of the securities described above, Barker transacted business in Wisconsin as an "agent" for JC Gear, AJ Comeau and AM Comeau, as that term is defined by sec. 551.02(2), Wis. Stats.
9. At no time has Barker been licensed as a securities agent pursuant to Ch. 551, Wis. Stats.
10. Barker has violated sec. 551.31(1), Wis. Stats., by transacting business in Wisconsin as a securities agent without a license.
