The staff of the Enforcement Unit, Registration & Enforcement Section, of the Division of Securities, Department of Financial Institutions, State of Wisconsin has conducted an investigation in this matter pursuant to sec. 551.56, Wis. Stats. and as a result thereof alleges as follows:

1. Pacific Air Transport, Inc ("Pacific Air") is a foreign business entity with last known business addresses of 6033 W. Century Blvd., Ste. 970, Los Angeles, CA 90045 and 12304 Santa Monica Blvd., Ste. 116, Los Angeles, CA 90025
2. Sebastian International Enterprises, Inc. ("Sebastian") is a foreign business entity with a last known business address of 1101 Delk Rd., Longwood, FL 32779.
3. Technical Support Services, Inc. ("Technical Support") is a foreign business entity with a last known business address of 1050 Kingsmill Pkwy., Columbus, OH 43229.
4. World Vision Entertainment, Inc. ("World Vision") is a foreign business entity with a last known business address of 285 National Pl., #127, Longwood, FL.
5. Phoenix Telecom, LLC, ("Phoenix Telecom") is a foreign business entity with last known business addresses of 1340 Center Drive, Suite 202, Atlanta, GA 30338 and 2611 Belt Line, Ste. 200, Sunnyvale, TX 75182.
6. Theodore R. Miller (CRD#: 2760427; DOB 05/02/62) ("Miller") is an individual with a last known address of 3157 Muir Field Road, #68, Madison, WI 53719.
7. At all times material hereto Miller was an insurance agent licensed by the Office of the Wisconsin Commissioner of Insurance, and a securities agent licensed by the Division.
8. During the period of 1998, Miller, on behalf of Pacific Air, offered and sold to at least one person in Wisconsin the promissory note of Pacific Air.
9. During the period of 1998 and 1999, Miller, on behalf of Sebastian, offered and sold to at least 10 persons in Wisconsin promissory notes of Sebastian.
10. During the period of 1998, Miller, on behalf of Technical Support, offered and sold to at least one person in the Wisconsin promissory note of Technical Support.
11. During the period of 1998, Miller, on behalf of World Vision, offered and sold to at least twelve persons in Wisconsin promissory notes of World Vision.
12. During the period of 1998, Miller, on behalf of Phoenix Telecom, offered and sold to at least seven persons in Wisconsin investment contracts of Phoenix Telecom.
