

The staff of the State of Wisconsin Department of Financial Institutions, Division of Securities, Bureau of Registration & Enforcement has conducted an investigation in this matter pursuant to sec. 551.56, Wis. Stats., and as a result thereof alleges as follows:


1. Superstars-N-Carz, LLC n/k/a RB Motorsports & Co., LLC ("SNC") is a foreign business entity with a last known business address of 5401 W. Lisbon Ave., Milwaukee, 53210;
2. Alaric L. Bowers a/k/a Rick Bowers (DOB 6/12/67) ("Bowers") is an individual who, at all times material hereto, has been President of SNC, with a last known residence address at that of 8990 N. Bethanne Dr., Brown Deer, WI. 53223;
3. During the period of June 2003, Bowers, on behalf of SNC, offered and sold to at least one person in Wisconsin a promissory note;
4. The promissory note is a security as that term is defined by sec. 551.02(13), Wis. Stats.;
5. At no time was the security registered pursuant to Ch. 551, Wis. Stats, for offer and sale in Wisconsin;
6. By selling unregistered securities, Bowers has violated sec. 551.21 Wis. Stats.;
7. At the time of the offer and sale referred to above, Bowers had almost \$10,000 in tax warrants filed against him, and was the subject of numerous lawsuits repossessing automobiles as well as a number of small claims actions;
8. Bowers did not inform the investor of any of the legal actions against him described in paragraph 7 above;
9. Bowers actions, in failing to disclose the existence of these actions, omitted to state a material fact necessary in order to make the statements made, in light of the circumstances under which they were made, not misleading, in violation of sec. 551.41(2), Wis. Stats.

Therefore, the staff of the Enforcement Unit petitions the Administrator of the Division of Securities for the issuance of the attached Order pursuant to Ch. 551, Wis. Stats.
