The staff of the State of Wisconsin, Department of Financial Institutions, Division of Securities, has conducted an investigation in this matter pursuant to sec. 551.56, Wis. Stats. and as a result thereof alleges as follows:

1. Upon information and belief, Premier Online Solution LLC aka Premier Online Solutions (“Premier Online Solutions”) is a foreign business entity with a last known business address of 4040 E. McDowell Road, Phoenix, Arizona 85008-4478 and mailing address of PO Box 80067, Phoenix, Arizona 85060-0067;
2. Upon information and belief, Ron Jones (“Jones”) is an adult individual who at all times material hereto was an owner, officer and/or a controlling person of Premier Online Solutions, with a last known business address at that of Premier Online Solutions;
3. Upon information and belief, Joe Caba (“Caba”) is an adult individual, who at all times material hereto was an agent of Premier Online Solutions and Jones, with a last known business address at that of Premier Online Solutions;
4. Upon information and belief, during the period of at least 2003, Caba, on behalf of Premier Online Solutions and Jones, offered and sold to at least one person in Wisconsin an investment involving interests in an Internet website business;
5. Upon information and belief, each investor will not be involved in the day-to-day operation and/or management of the website, since they do not have the expertise or experience necessary to perform its duties;
6. Since the investors will be involved in a common enterprise with the expectation of profits to be derived from the essential managerial efforts of others, the interests in the website business offered and sold by the respondents are investment contracts as defined by section DFI-Sec. 1.02(6)(a), Wis. Adm. Code, and are therefore securities as defined by sec. 551.02(13), Wis. Stats.

7. The investment contracts of Premier Online Solutions have never been registered for offer and sale in Wisconsin pursuant to Ch. 551, Wis. Stats.;

8. All Respondents have violated sec. 551.21(1), Wis. Stats., by offering and selling unregistered securities to persons in Wisconsin;

9. In connection with the offer and sale of the securities described above, Caba transacted business in Wisconsin as an "agent" for Premier Online Solutions, and Jones as that term is defined by sec. 551.02(2), Wis. Stats.;


11. At no time has Caba been licensed as a securities agent pursuant to Ch. 551, Wis. Stats.;

12. Caba has violated sec. 551.31(1), Wis. Stats., by transacting business in Wisconsin as a securities agent without a license;


13. Premier Online Solutions and Jones have violated sec. 551.31(2), Wis. Stats., by employing an unlicensed agent to represent them in Wisconsin; and

14. Staff of the State of Wisconsin, Department of Financial Institutions, Division of Securities, wrote to Premier Online Solutions to request information and documents concerning their securities-related transactions with persons in Wisconsin, but to date have received no response.

Therefore, the staff of the State of Wisconsin, Department of Financial Institutions, Division of Securities, petitions for the issuance of the attached Order pursuant to Ch. 551, Wis. Stats.
