Washington Avenue, 5th Floor, Madison, Wisconsin 53703 to consider the matters set forth in s. 227.44(4), Stats. Respondent represented by counsel must attend this conference unless the hearing examiner excuses respondent's appearance. Failure to attend this prehearing conference may constitute a default.

7. The respondent is required to make answer to this notice in writing by 4:30 p.m. on Tuesday, January 17, 2006. The answer shall be received by the hearing examiner by this time and date. Failure to answer this notice by this time and date may constitute a default.
