The staff of the State of Wisconsin, Department of Financial Institutions, Division of Securities, has conducted an investigation in this matter pursuant to sec. 551.56, Wis. Stats. and as a result thereof alleges as follows:

1. Marco Glisson ("Glisson"), date-of-birth of February 28, 1955, is an individual with a last known address of 2200 S. Fort Apache Road, Apartment 2017, Las Vegas, Nevada 89117. Upon information and belief, from at least December 2005 through May 2006, Glisson resided at 1026 N. Washington Street, Janesville, Wisconsin 53546;
2. Upon information and belief, during the period of at least December 2005 through May 2006, Glisson purchased and sold millions of shares of stock in CMKM Diamonds, Inc. ("CMKM") to individuals across the United States including at least one person from Wisconsin.;
3. Upon information and belief, the Wisconsin transaction referred to in Paragraph 2 above consisted of the sale of shares of stock in CMKM;
4. In an August 20, 2007 deposition of Glisson conducted by the U. S. Securities and Exchange Commission ("SEC"), Glisson admitted that between December 2005 and May 2006, Glisson was involved in various securities transactions of CMKM where he would buy shares of CMKM stock and resell those shares to other individuals;
5. Upon information and belief, based on the sales of the securities described above, Glisson transacted business in Wisconsin as a broker-dealer, as that term is defined by sec. 551.02(2), Wis. Stats.;
6. At no time has Glisson been licensed as a broker-dealer pursuant to Ch. 551, Wis. Stats.;
7. Glisson has violated sec. 551.31(1), Wis. Stats., by transacting business in Wisconsin as a broker-dealer without a license;
8. On March 3, 2005 the SEC temporarily suspended all trading in CMKM; to date the suspension has not been lifted;
9. CMKM has never been registered under Ch. 551, Wis. Stats.

10. Respondent has violated sec. 551.21(1), Wis. Stats., by offering unregistered securities to at least one person in Wisconsin.

Therefore, the staff of the State of Wisconsin, Department of Financial Institutions, Division of Securities, petitions for the issuance of the attached Order pursuant to Ch. 551, Wis. Stats.
