The staff of the State of Wisconsin Department of Financial Institutions, Division of Securities, Bureau of Registration & Enforcement has conducted an investigation in this matter pursuant to sec. 551.56, Wis. Stats., and as a result thereof alleges as follows:

1. Multiple One Group, Inc. ("MOG") aka Guardian International Travel ("GIT") is a Nevada corporation, as of June 27, 2007, with a last known business address of 2600 Ring Road, Elizabethtown, Kentucky 42701.
2. Swainson Hawke ("Hawke") is an individual who at all times material hereto was owner and Chief Executive Officer of MOG, with a last known (business) address as that of MOG, 2600 Ring Road, Elizabethtown, Kentucky 42701.
3. Riley E. Fitzsimons ("Fitzsimons") is an individual who at all times material hereto was an agent of MOG, with a last known home address of 213 E. River Street, Darlington, Wisconsin 53530.
4. During June 2007, Fitzsimons, on behalf of all other respondents, offered and sold to at least one person in Wisconsin shares of stock in MOG.
5. The MOG stock is a security as defined by Sec. 551.02, Wis. Stats.
6. The MOG stock has never been registered for offer and sale in Wisconsin pursuant to Ch. 551, Wis. Stats.
7. All respondents have violated sec. 551.21(1), Wis. Stats., by offering unregistered securities in Wisconsin.
8. MOG was engaged in several business ventures including, but not limited to: FOREX and Hawk's Hospitality, Inc.
9. Upon information and belief, Respondent Fitzsimons received a commission for the sales of interest in MOG that he made.
10. At no time material hereto was Fitzsimons licensed as a securities agent in Wisconsin pursuant to 551, Wis. Stats.
11. Fitzsimons has violated sec. 551.31(1), Wis. Stats., by transacting business in Wisconsin as a securities agent without a license.
12. Respondents MOG and Hawke have violated sec. 551.31(2), Wis. Stats., by employing an unlicensed agent to represent them in Wisconsin.

Therefore, the staff of the Bureau of Registration & Enforcement petitions the Administrator of the Division of Securities for the issuance of the attached Order pursuant to Ch. 551, Wis. Stats.
