WHEREAS, on the basis of the foregoing, the Summary Order of Prohibition and Revocation issued in this matter is no longer necessary in the public interest or for the protection of investors; and

WHEREAS, on the basis of the foregoing, this Order is found to be appropriate in the public interest and for the protection of investors,

NOW, THEREFORE, pursuant to Wis. Stat. § 551.604(4),

IT IS ORDERED that the Summary Order of Censure and Prohibition herein dated January 12, 2011 against the Respondent is hereby vacated.

PROHIBITION & REVOCATION



The staff of the State of Wisconsin, Department of Financial Institutions, Division of Securities, Bureau of Enforcement, has conducted an investigation in this matter pursuant to § 551.56, Wis. Stats.,¹ and as a result thereof alleges as follows:

1. Brenda L. Myers is an individual with a last known address of 4606 Signature Drive, Middleton, WI 53565, and is the wife of Charles M. Myers.
2. On January 12, 2011, the staff petitioned for Orders of Prohibition and Revocation against Brenda Myers and others, and an Order was issued against Brenda Myers by the Administrator on January 12, 2011.
3. The allegations set forth in the petition referred to in ¶2, if proven, would give rise to a violation of the Wisconsin Uniform Securities Law, Chapter 551, Wis. Stats.
4. The Division staff and Respondent have reached an agreement in resolution of the matters alleged in the Petition, making a hearing in the matter unnecessary.
5. Therefore, it is in the public interest and for protection of investors that the staff agree to vacate the outstanding Petition for Summary Order of Prohibition and Revocation issued against Brenda Myers on January 12, 2011, and agree that the attached Order to Vacate Summary Order of Censure and Prohibition be issued.

Therefore, the staff of the Bureau of Enforcement petitions the Administrator of the Division of Securities for the issuance of the attached Order pursuant to Ch. 551, Wis. Stats.
