IT IS HEREBY stipulated and agreed to, and consented by and between Mariann Sankey ("Sankey") and the State of Wisconsin, Department of Financial Institutions, Division of Banking ("division") as follows:

1. Sankey was duly and properly served by the Administrator of the division with a Notice of Assessment of Forfeiture and Limitation of Registration ("Notice") in the above-referenced matter. The parties to this stipulation and consent hereby incorporate by reference the Notice as if set forth fully herein.
2. Sankey consents to the assessment of forfeiture as set forth in the Notice.
3. Sankey consents to the limitation of her certificate of registration and the reporting requirements as set forth in the Notice.
4. Sankey consents to the cease and desist as set forth in the Notice.
5. Sankey consents to the remaining provisions, terms and conditions of the Notice.
6. Regarding the assessment of forfeiture, Sankey waives her right to any further proceedings in the above-referenced matter, including but not limited to any hearing under s. 224.77(1m), Stats., or ch. 227, Stats.
7. Regarding the limitation of registration, Sankey waives her right to any further proceedings in the above-referenced matter, including but not limited to any hearing under ch. 227, Stats.
8. Regarding the cease and desist, Sankey waives her right to any further proceedings in the above-referenced matter, including but not limited to any hearing under ch. 227, Stats.
9. Sankey agrees that the provisions of this Stipulation and Consent to Assessment of Forfeiture and Limitation of Registration, and the terms and conditions thereof, shall be binding upon Sankey.

10. Sankey agrees that the provisions of this Stipulation and Consent to Assessment of Forfeiture, Limitation of Registration and Cease and Desist, and the terms and conditions thereof, shall remain effective and enforceable except to the extent that, and until such time as, any provisions therein shall have been modified, terminated, suspended or set aside by the Administrator.
